# MINUTES OF 2023 ANNUAL MEETINGS

Eastminster Presbyterian Church, East Lansing, MI Annual Meeting of the Congregation/Corporation January 29, 2023

The annual meeting of the congregation of Eastminster Presbyterian Church, East Lansing, Michigan, was held on Sunday, January 29, 2023, at 10:50 A.M., immediately following worship service, in the church sanctuary. The moderator, Rev. Kristin Stroble, called the meeting to order, declared there was a quorum and opened with prayer.

Linda Hardenbergh moved that this meeting constitute the annual meeting of the corporation of Eastminster Presbyterian Church for 2023, and that its proceedings and conclusions are the actions of the corporation. The motion was supported by Sam O'Neill and was carried.

Minutes of the two congregational meetings in 2022 were provided by email and at the meeting, as part of the 2022 Annual Report. Both had been previously approved by the session.

Robin Bell presented the nominating committee report and placed in nomination its slate of at-large members: Rick Johnston, Irv Nichols, Mary Harvey and Linda Hardenbergh. Rev. Stroble asked for additional nominations from the floor; there were none. Robin Bell moved to close nominations and cast a unanimous ballot for these at-large nominees. The motion was seconded by Mike Brown and was carried.

Treasurer Bob Kleine presented the financial reports and budget. 2022 ongoing income of \$297,855 exceeded budgeted income and actual expenses of \$341,094 were lower than budgeted expenses. The year began with a beginning balance of \$36,419. The negative ending balance of \$6,260 was covered by a transfer from endowment income, designated to cover much of the costs of repaying the renovations loan. Both the endowment and reserve accounts suffered from the year's poor stock and bond prices with year-end balances of \$806,042 and \$99,084 respectively. Church indebtedness was \$88,519, owed to Presbyterian Investment and Loan and incurred for renovations/replacements of the church roof, parking lot and air conditioners.

The 2023 budget was presented. There were no questions or comments. Mike Brown moved to receive the treasurer's report. The motion was seconded and carried.

Linda Hardenbergh reviewed the pastor's terms of call for 2022, with a salary increase of 3%. Mike Brown moved to approve the pastor's terms of call. The motion was seconded by Sam O'Neill and carried.

Sam O'Neill moved to adjourn. The motion was seconded by and carried. The meeting was adjourned with prayer at 11:00 A.M.



# FINANCIAL REPORTS

#### 2023 Financial Overview

#### Balance Sheet

 The balance sheet shows a financial snapshot of a single moment in time. It lists the church's assets such as our bank accounts and investment accounts; our liabilities such as the interest and principal of the renovations loan; and money designated for specific funds.

#### Consolidated Fund Report

o The fund report shows all of the designated funds of the church. A designated fund means that money given to that account must be spent on whatever it was given for. For example, a gift to the music fund must be spent on the music ministry of the church. These funds are outside the operating budget and can carry over from year-to-year. Some of these are called "pass-through" funds because money is donated for a cause and does not stay with Eastminster.

#### Treasurer's Report

The Treasurer's Report is an accounting of the church's operating budget and how it was spent. Each budget covers a one-year period and is tracked by this report. Any monies coming in and out that are not allocated to a designated fund are recorded in this report. This report is a final look at all the income and expenses of the church in 2023.

#### 2024 Budget

### 2023 Financial Overview


The 2023 budget turned out better than expected as income exceeded projections, for the fifth consecutive year, and expenditures were less than projected.

Operating income for 2023 was \$314,991, which was \$17,987 more than estimated. Member

giving exceeded the estimate by \$12,265 and plate revenue by \$4,270. This was largely due to 13 members giving more than pledged and \$5,415 from 2021 pledges that had been incorrectly posted. The church also received significant contributions from several individuals who did not pledge, which is counted as non-pledged giving.

Total income was \$333,946, which includes a transfer of \$10,000 from reserves and \$8,668.10 from endowment income.

We also received \$13,991 for the Federal Employee Retention




Note: Actual total income is lower than budgeted because we did not withdraw as much from reserves or endowment as budgeted. Actual earned income—primarily pledges and non-pledged giving—exceeded budgeted amounts.

Credit (ERC) in 2023. Of that money, \$9,600 was used to eliminate the negative balance in the Capital Improvement Fund and \$4,216 was refunded to UKirk based on salary percentages (see explanation on p. 29). We expect to receive additional ERC credits in 2024, but the timing is currently unknown.

The adopted 2023 budget was \$355,434. Actual expenses were \$333,946, \$21,488 less than budgeted. The major differences were \$5,767 not spent by the Mission Committee (an unusual occurrence), \$3,655 savings for structural maintenance and repair, and \$3,200 savings for snow removal.

Operating income for 2023 was \$314,991, which was \$17,987 more than estimated. Member giving exceeded the estimate by \$12,265 and plate (non-pledged giving) revenue by \$4,270.



Expenditures for 2023 were 2.1% less than 2022 expenditures.

The ending balance for 2023 was a negative \$8,668.10, which as noted above, was covered by a transfer from endowment income. (This amount tracks closely to the \$8,194 spent annually to repay the renovations

loan.) The actual budget shortfall was \$18,951, as \$10,000 was transferred from reserves earlier in the year. The budget shortfall was originally estimated at \$61,097.

As noted, this was a much better outcome than expected, but we are facing serious budget challenges in the future. We are projecting a budget shortfall of \$62,022 for the 2024 budget. Overall, the church's finances are strong. Our reserves at the end of 2023 were \$102,097 and our endowment funds were \$865,731. For 2024, we have 53 pledges totaling \$263,470.


Our expenditures continue to exceed revenue, due in large part to inflation and member deaths, but there is a strong commitment to develop a five-year plan that will

reduce our reliance on reserves and endowment income. We are receiving planning assistance from the Presbyterian Foundation.

However, it will not be easy as we have already made substantial cuts in the budget in the past few years. Personnel accounts for 62% of the budget and building and grounds for 19%, leaving little room for significant budget cuts.

The generous support of our congregation continues to be a blessing.



# **ENDOWMENT AND INVESTMENTS REPORT**

Eastminster Presbyterian Church began the year with an endowment fund balance of \$806,042 and ended the year with a balance of \$885,969.51. We withdrew 4% of the fund, or \$33,090, paid an investment fee of \$8,064 (1%), and experienced an investment gain of \$121,081.33, or 15%. The S&P 500 stock index increased 24.5% in 2022. Our stock holdings increased 21.5%, and our bond holding increased 8% (adjusted for withdrawals and fees).

At the end of 2022, the endowment fund was comprised of 58.6% in stocks and 41.4%

in bonds and cash. At the end of 2023, the endowment fund was comprised of 63.3% in stocks and 36.7% in bonds and cash. Our investment policy sets a range of 40%-65% for stocks and 30%-50% for bonds.

We withdrew 4%, or \$33,090, paid a fee of \$8,064 (1%), and experienced an investment gain of \$121,081.33, or 15%.

The Endowment Income Fund had a year-end balance of \$35,054. There was

one expenditure of \$368.17 from the fund for security cameras and \$8,668.10 was transferred from the fund to cover a shortfall in the 2023 budget. The transfer of funds was approved by the committee and by Session.

In addition to the Endowment Fund, the church has a substantial reserve fund. The church's reserves are held by LPL Financial and managed by BlackRock investment management company. We have two accounts. The reserves in the Growth with Income Portfolio account were valued at \$99,084 at the beginning of the year and ended the year with a balance of \$102,097, an investment gain of \$13,103, adjusting for a \$10,000 withdrawal from the reserves in the first quarter of the year for cash flow purposes. Adjusted for this withdrawal, the value of our reserves increased 13.1% in 2023. The reserves are comprised of 61.7% in stocks and 38.3% in bonds and cash. We also have a trading account through



which stock donations pass through. The account started the year at \$975.96. A donation of \$12,200.65 was made the final week of the year and will be disbursed in 2024. The account currently stands ar\$13,108.59 with an investment loss of \$68.02.

In late 2023, we purchased a \$25,000 7-month CD at dfcu

# CHURCH INDEBTEDNESS REPORT

In 2020, the church took out a \$100,000 loan at 2.837% interest to pay for renovations, including a new roof, resurfacing and sealing the parking lot and installing new air conditioners in the sanctuary.

We paid for the down payment of the loan out of our capital improvements fund, leaving a negative balance in that account. In late 2023, we paid off the loan to ourselves from that account with money from the Employee Retention Credit.

# PANDEMIC-RELATED TAX CREDIT

Eastminster qualified for the Employee Retention Credit, a tax rebate offered as part of the pandemic-relief package. In late 2022 and early 2023, we worked with Innovation Refunds, an organization recommended by our bank, Horizon.

They determined that for quarters 2020 Q2 through 2021 Q3 we qualified for \$99,455.88 in refunds or "recovery." We will be paying them a 25% fee as we receive each check. Our anticipated receipts after paying the

fees are \$74,591.91.

As of Sept. 12, 2023, we have received a refund of \$17,824.39, of which we paid \$3,832.86 to Innovation Refunds.

Because of a high degree of fraud from many filers, the IRS has slowed approvals and refunds. We do not know when we will get the remaining monies.

This is a rebate based on payroll, so a portion of the rebate went to UKirk, which pays half of Neil Myer's salary. Rev. Kristin Stroble's salary was excluded from calculations because of her status as a minister. Session then determined, at the recommendation of the Infrastructure committee, that we use the refund received to eliminate the negative balance we have been carrying in the capital improvements fund since our renovations loan was taken out in 2020.


